Those who qualified are compulsory to attend.

### **ENTRY / ELIGIBILITY CONDITIONS:**

- a) Malaysian amateur golfers with a handicap 5 and below for men and handicap 6 and below for women.
- b) Entry fee is RM800/= per player to be paid in CASH only and payable before 18 February 2018. **(RM500 will be collected first and remaining RM300 and RM200 (Annual Subscription) upon qualifying.**

### **QUALIFYING STANDARD**

The qualifying standard for the two days tournament is +8 for men and +10 for women. Once qualified you are required to provide 20 hours of services or participation in an event / seminar organized by PGAM during one year probation period.

### **WITHDRAWAL**

Any withdrawal 48 hours BEFORE the registration day for Stage 1, 50% of entry fee shall be forfeited, except for emergency or medical circumstances. Any withdrawal during the Trial, the entry fee shall be forfeited.
